Privacy policy of Prismace Consultancy

Personal data is processed via the website www.prismace.eu and cookies are used. We consider careful handling of personal data of great importance. The personal data collected by us are therefore carefully processed and secured by us. In our processing, we comply with the requirements set by the Personal Data Protection Act or the General Data Protection Regulation.

Personal data that we process

Prismace Consultancy processes your personal data because you use our services and / or because you provide them yourself.

Below is an overview of the personal data that we process:

- First and last name
- Address data
- Telephone number
- E-mail address

Other personal data that you actively provide in correspondence and telephone contact

- Internetbrowser and device type
- Preferences for specific services

This information is processed by us based on a legitimate interest, namely the establishment of contact through our contact form;

You can withdraw your consent to the personal details mentioned at any time. As soon as you withdraw this permission, we will no longer process this personal data. However, the withdrawal of your consent does not affect the lawfulness of the processing of these personal data prior to this withdrawal.

We do not store your personal data longer than is necessary for achieving the purposes and the applicable legal terms for the storage of data.

For what purpose and on what basis we process personal data

Prismace Consultancy processes your personal data for the following purposes:

- Sending our newsletter
- You can call or e-mail if necessary, to carry out our services
- To be able to inform you about changes to our services and products accountants tax consultants

Contact Form

If you fill in the contact form on the website, or send us an e-mail, the data you send us will be kept for as long as the nature of the form or the content of the e-mail message is required for the complete answering and handling thereof.

Special and / or sensitive personal data that we process

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. However, we cannot check if a visitor is older than 16. We therefore encourage parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent. If you are convinced that we have collected personal data about a minor without this permission, please contact us via info@prismace.eu and we will delete this information.

Share with others

Prismace Consultancy will not sell your information to third parties and will only provide this information if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

Mapping website visit

Prismace Consultancy uses only technical and functional cookies. And analytical cookies that do not infringe your privacy. A-cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and remember, for example, your preferences. We can also optimize our website with this. You can opt out of cookies by setting your internet browser so that it does not store cookies anymore. In addition, you can also delete all information previously saved via the settings of your browser.

View, modify or delete data

You have the right to view, correct or delete your personal data. You can send us a request for access, correction or deletion to info@prismace.eu. You also have the right to transfer your personal data to a third party. In order to ensure that the request for access has been made by you, we ask you to send a copy of your identity document with the request. In this

copy we ask you to black your passport photo, citizen service number, passport number and MRZ (machine readable zone, the strip with numbers at the bottom of the passport). This is to protect your privacy.

We will comply with such requests as quickly as possible, but within 4 weeks, or provide a motivated explanation of why your request can not (yet) be executed.
